- Lead agency for the Coordinated Assessment & Referral System (CARS) Ensure those in highest need receive services first
- Coordinate Shelter & Unsheltered Point-In-Time (PIT) Census to determine the number of homeless individuals in the area
- Member Agencies: Hosing Authority, Interim, Community Human Services, HRC, Community Homeless Solution, etc.

• 2019 stats/results: Counted anyone living on the streets or in shelters, 2422 on that day in MC

76% of homeless live unsheltered in Monterey County, 50% San Benito County

95% 25+ age, range is increasing, 14% youth

Monterey County 4% currently experiencing Physical, Emotional, Substance abuse currently, expected that it is a higher percentage than what was reported

26% of singles homeless du to Physical, Emotional, Substance abuse 35% of families homeless due to Physical, Emotional, Substance abuse

- CARS: "The way home", Assessment is used to prioritize needs, long wait list, work with the network of agencies to see how many beds they have so they can use the CARS list to see if the client would be a good fit for a program, higher priority given for chronically homeless over 1 year, once a good fit is found the client is called. They have 3 chances to get back in touch (3 days)
- DV survivors have separate procedures, Take the CARS with 2 specific questions about DV. If they confirm they are then connected to the YWCA or MCRCC. They are then required to complete the assessment on paper & fax it in. The name is changed on the master list for confidentiality and safety, standard procedure followed from there, emergency transfer can be requested if there is threat to imminent harm, must contact housing provider to file a formal request

ii. Lower bails, released easily, could be increasing difficulty related to leaving their abuser, difficulty placing individuals on parole or probation – Kathy & Ryan

iii. Schools were working to put all plans together, due to spike in cases and being placed on the watch list the Gov required schools not open to on-site instruction. Watch list off for 14 days to begin modified plans that have been worked on following all proper protocols. If there is a breakout at the schools they may close the classroom or school depending on size, if 25% of district breakout the whole district will close – Deneen
