### 3. Education and Information

Presentation by Elaine McCleaf on DV and animal abuse. Open discussion on case.

Case concluded during shelter in place. This couple had been seeing each other  $\sim$ 3 years, they never lived together, the victim was living w/ her parents. Victim indicated prior DV with no reports. In December of 2018 at 5am the victim was in a detached room w/ her

friend. defendant had texted and called her and she had not responded. He showed up at the home, kicked open the door and began to argue with the victim. He punched her in the head, followed the girls into the house, and the parents began pushing him out of their home. The defendant broke their windows, mom pushed him away and he grabbed a 6in blade swinging it at the mother. Her 1 year old pit bull dog lunged at the suspect and he stabbed the dog in the chest. The dog died on the spot. Dad came in and the man would not leave, here forward there is a gap in details. Somehow the dad subdued the defendant in the bedroom until the police came, defendant had a gushing head wound.

Elain McCleaf described the released 911 tape:

The victims friend calmly stated "We have an asssault."

911 operator: "Where are you? "

Hear clearly people screaming "...put the gun down, put the gun down..."

Caller: "...he has a gun..."

911: "...who is it?"

Caller: "Someone's been shot!"

911: "Where are you? Who has shot who?"

Caller: "....somebody's been shot... the dog has been shot..."

911: "... no person has been shot? Officers are on their way..."

Officers arrive 5:20am, shown on the officer body cameras and their testimony: Girls are in the yard and they lead the officer down the side yard with guns out. They tell victim and her friend to stay in the front; they don't listen running back to where the suspect is. Officers trying to control the women, other officers go back with guns drawn. They see that the victims dad is on top of the defendant, a deceased dog, and blood. They ask the individuals for the gun, "...we don't have a gun...". The dad is angry "...you killed my dog..." The officers do a search and can't find a gun. Officers talk to the suspect and he is slurring his words and he took cocaine prior to this event. The officers lead him out of the yard. The Mother has a head wound. Victim says "...let mom fuck him up..." The defendant was taken to Natividad in custody. Officers continue their investigation. They ask if Mom wants to press charges on the attack against the dog, but in order to do so the officers say they must take the body to which mom declines. Officers didn't fully explain the process. (They do not need her permission to take the body nor do they explain that the body can have an autopsy done and the remains can be cremated and given back to the mom). The dog was stabbed in the heart and died quickly based on the investigation. The officers asked the friend why she said there was a gun? "I never saw,

my friend said there was." They then asked the victim "Did you see a gun?" Victim: "I never saw one but he always has one or it's in his car."

An emergency protective order was granted for the victim at 820a. At 9a Natividad alerts officers that the defendant has a brain injury that needs surgery and he is released from custody due to hospitalization. The officers submit a warrant request for re-arrest once he's released from the hospital so officers can be released from the hospital and return to regular duty. The police can ask the hospital to notify when the defendant is released, but that did not happen so he was free and at large after being released from Natividad.

January 31<sup>st</sup>, 45 days later, Soledad sends the District Attorney's office an arrest warrant. The office files charges April 2<sup>nd.</sup>

In March the defendant sees the victim in a car with another man and he rams their car with his. He was arrested for assault with a deadly weapon and bails out. This case was filed with the previous case to which he was charged with 1 felony charge of animal cruelty and misdemeanor domestic violence.

He was arrested July 11<sup>th.</sup> A criminal protective order was granted at his arraignment for the victim only, not the parents. The district attorneys office victim advocate department tries several times to get in contact with the family in regards to the case. The report numbers for all the cases were not up to date causing confusion for the advocates, the advocate called Soledad PD to get current numbers. At this point the victim refuses to testify at all and the mother will only testify against the animal abuse, but can't because she didn't see what happened.

August 1<sup>st</sup> the defendant was denied release on his own recognizance. The case was then given to ADA McCleaf who upped his charges to felonies and added breaking and entering.

August 12<sup>th</sup> he made bail and was required to attend NA/AA meetings weekly while at large. During this time the victims mother continued to see him drive past their house regularly. She called the police. The police look up in CLETS (filing system) for the criminal protective order put in place back in July. The officers state they can't find any record of the order and are unable to arrest the defendant for violating the order since the mother was not able to present her copy either.

In October McCleaf offers the defendant a 3 year 8 month sentence, but is unable to contact the victim at all during December and January to get her input.

In January the defendant gets a new attorney that states that the client has a traumatic brain injury due to the incident and he lacks the understanding of the criminal justice system. If this defense were to pass his charges would be suspended.

On March 10<sup>th</sup> the defendant pleads guilty and the advocates are able to speak with the mother who stated that she wished for a steeper sentence because he killed her dog. The advocate explained that she may write a letter to present at sentencing.

June 1<sup>st</sup> and June 2<sup>nd</sup> the advocates left messages with the mother, she replied that they will not attend the sentencing, but they will write letters. On June 11<sup>th</sup> the mother emails her statement that states "... he hit JD (the father) in the face, scraped my face, stabbed and killed my pet... she's (the victim) going through a lot of changes... trust issues... he keeps passing by our house and my job... reported restraining order violation but they let him go... I am asking for 15 years.... our lives will never be the same..." Judge Hood remanded him and ordered 365 days w/ 50% credit = 180 days followed by the remaining time on probation. He faces 3 years and 8 months in prison if he violates any of his probation terms.

### Discussion:

Kathy: County becomes liable for bill if defendant is in the hospital while in custody. Sometimes they will hire security companies to watch the patient depending on case.

Jeff: Default is that the officers will not sit on someone in the hospital unless they are an extreme risk; they will arrest at a later time

Christine: There has been a correlation between animal abuse and DV

Pam: The advocates continually call victims before each court date to alert them of the status

Elaine: This case is an example of how each agency needs to cooperate
