#### IV. AGRICULTURAL COMMISSIONER'S UPDATE

Henry Gonzales, Agricultural Commissioner

- On June 23, 2020, the 2019 Crop Report was presented at a Zoom media event and later in the day to the Board of Supervisors. The theme for 2019 was Invasive Species. A video on this topic also was released. The first Cannabis Crop Report was presented at the same time as a separate publication;
- We have received complaints about growers not enforcing COVID-19 safety protocols, which were referred to the Health Department for follow up;

- A credit-card sized information card is being distributed to farmworkers indicating they
  are essential workers. The card includes information on COVID-19 symptoms and
  resources available;
- Face masks were received from CDFA and the County for distribution to farmworkers;
- About 20% of our staff are working from home.
