Groundwater recharge systems are often used to recharge groundwater in areas that have been depleted to improve groundwater quantity and quality, as well as improve connected aquatic systems such as creeks, rivers, wetlands, and estuaries.

ACTION REQUESTED: Provide feedback on how these mitigation efforts are perceived and if Caltrans should pursue groundwater recharge as one of the options for future mitigation efforts.
